**REMINDER ON EXAMINATION SECURITY AND PROHIBITION
OF RECORDING AND POSTING DURING THE
ADMINISTRATION OF THE COMPUTER-BASED NATIONAL
CAREER ASSESSMENT EXAMINATION (CB-NCAE)**

1. In accordance with Advisory No. 004, s. 2026 (Reminder on Examination Security and Prohibition of Recording and Posting During the Administration of the Computer-Based National Career Assessment Examination [CB-NCAE]) and Regional Memorandum No. 90, s. 2026 (Reminder on Examination Security and Prohibition of Recording and Posting During the Administration of the Computer-Based National Career Assessment Examination [CB-NCAE]), this Office, through the School Governance and Operations Division (SGOD), hereby reminds all concerned school personnel to **uphold the security and integrity** of the ongoing administration of CB-NCAE.

2. Section 13 of DepEd Order No. 55, s. 2016 states that *“the security and integrity of test materials shall be upheld in the whole process of test administration.”* Furthermore, the following acts, among others, are deemed violations of examination security:

- a. Capturing test items through electronic gadgets
- b. Distribution and posting of photos of the test booklet in any form of media
- c. Failure to closely monitor test procedures resulting in test irregularities

3. Any breach of examination security by examinees or testing personnel will result in appropriate sanctions.

4. School Heads and testing personnel are reminded to strictly adhere to the examination rules and procedures.
