DIVISION CHECKING OF SCHOOL FORMS FOR PUBLIC AND PRIVATE SCHOOLS FOR SY 2025-2026

1. Pursuant to DepEd Order No. 11, s. 2018 (Guidelines on the Preparation and Checking of School Forms), the Schools Division of Imus City shall conduct the annual checking of school forms for SY 2025-2026 starting March 23, 2026.
2. The activity aims to ensure the accuracy, consistency, and reliability of learner information. This also serves as a mechanism for validating data in the Learner Information System (LIS) and for ensuring compliance with DepEd policies on enrolment, promotion, retention, and completion.
3. The Division Checking Committee (DCC) shall conduct checking for priority grade levels (Kinder, Grade 1, Grade 6, Grade 7, Grade 10, Grade 11, and Grade 12) and other levels based on the school size sampling guide. The DCC shall coordinate with the assigned public and private schools to determine the specific date and venue of physical checking of school forms. Below is the timeline of onsite checking of forms.

4. School heads shall establish a School Checking Committee (SCC) to conduct a thorough review of all learner records across all classes prior to the DCC's scheduled visit.

5. To ensure efficiency and reliability of the process of the Division Checking of Forms, cross-checking of school forms shall be conducted among schools within the same cluster or DCC groupings. The cross-checking shall be among schools within the same cluster/DCC groupings only. Specific arrangements for the cross-checking shall be on the discretion of the DCC subgroup chairperson. However, the "No Disruption of Classes Policy" must be observed and maintained during the checking of all school forms in adherence to DepEd Order No. 9, s. 2025 (Instituting Measures to Increase Engaged Time-On-Task and Ensuring Compliance Therewith).
6. The SCC and DCC shall follow the checking guidelines and forms prescribed in DO 11, s. 2018.
7. All schools are directed to prepare the following for review and validation:
 - a. LIS Generated SF 1, 2, 4, 5, and 6;
 - b. Accomplished School Form 10; and
 - c. Accomplished School Form Checking Report (SFCR1) signed by the School Checking Committee (SCC).
8. For reference, the following are enclosed in this Memorandum:
 - a. Enclosure No. 1 - Composition of the Division Checking Committee;
 - b. Enclosure No. 2 - Groupings of Public Schools for the Onsite Checking of School Forms; and
 - c. Enclosure No. 3 - Groupings of Private Schools for the Onsite Checking of School Forms.
9. There will be a DCC coordination meeting on **March 16, 2026**, 2:00 PM at the Bulwagang Imuseny, SDO Imus.
10. Upon completion of the checking process, the DCC is responsible for verifying that all School Forms Checking Reports (SFCR) are finalized and consolidated. The chairman of each group shall also submit a narrative report detailing school observations, supported by figures/statistics recorded in the SFCR.
