In reference to DepEd Memorandum No. 100, s. 2025 (2025 Accreditation and Equivalency Test Registration and Administration Guidelines), the Curriculum Implementation Division, through the Alternative Learning System (ALS), shall conduct the Presentation Portfolio Assessment (PPA) for ALS Accreditation and Equivalency (A&E) Test registrants from March 17-19, 2026.
2. This activity aims to assess registered ALS A&E learners as part of the requirements for their qualification to take the A&E Test.
3. The Presentation Portfolio is composed of the following components:
  - a. Ten (10) Formal Records; and
  - b. Thirty-five (35) Work Samples covering six (6) Learning Strands.
4. All ALS Teachers, Community ALS Implementers, and Learning Facilitators are expected to prepare the learners' presentation portfolios prior to the scheduled date of assessment.


