FOR S.Y. 2025-2026**

1. In reference to Regional Memorandum No. 140, s. 2025, this Office, through the School Health and Nutrition Section, informs the field of the conduct of the Second Round of School-Based Deworming Activity for S. Y. 2025-2026 in all Public Schools starting January 19 to February 20, 2026.
2. This activity aims to:
  - a. deworm all school-aged children from Kindergarten to Grade 12 learners
  - b. reduce Soil Transmitted Helminthiasis (STH) infections with positive
  - c. improve nutritional status and intellectual ability of learners; and
  - d. make them active and productive in school
3. All schools are enjoined in promoting the Deworming Program through advocacy. Schools are also requested to secure the signed parental/ guardian consent form before the conduct of the said activity and advise using the Annex C: Form 4b Division Level IHCP Reporting Form

5. SHNS personnel will coordinate with the school head and designated school health coordinator to approve the scheduled date of the deworming activity.
