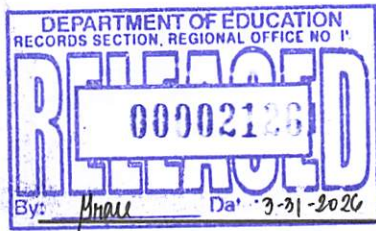



WHEREAS, in order to strengthen institutional coherence, clarify roles and responsibilities of member agencies and private sector representatives, and ensure sustained implementation of migration-related programs, the CMD has formulated its Terms of Reference (TOR) for the period 2025–2028;

WHEREAS, the said TOR outlines the Committee's mandate, structure, operational mechanisms, coordination protocols, reporting framework, and monitoring and evaluation provisions consistent with regional development priorities and the broader migration and development agenda;

WHEREAS, the formal endorsement of the 2025–2028 TOR to the RDC IV-A is necessary to institutionalize the Committee's framework, reinforce its policy alignment with the Regional Development Plan, and secure the appropriate recognition and support of the Council;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby **RESOLVED**, that the Committee on Migration and Development hereby endorses its Terms of Reference for 2025–2028 to the Regional Development Council IV-A for consideration and approval.
