**SCHOOL-BASED FEEDING PROGRAM (SBFP) – NUTRITIOUS
FOOD PRODUCT (NFP) IMPLEMENTATION FOR THE
SY 2023-2024**

1. Relative to Regional Memorandum No. 229, s. 2023 (Regional Supplementary Guidelines on the Implementation of School-Based Feeding Program for SY 2023-2024), this Office, through the School Health and Nutrition Section (SHNS), shall implement the School-Based Feeding Program (SBFP) - Nutritious Food Product (NFP) on September 18, 2023 to March 1, 2024 (120 days), with a total 2,078 beneficiaries from the 25 public elementary schools and one (1) public integrated school.
2. The schedule for the distribution of food commodities of the SBFP-NFP will be announced in the Group Chat of SBFP Coordinators. See Enclosure 1 for the three (3) drop-off points and assigned schools for each drop-off point. SHNS personnel shall be in the drop-off points to monitor the distribution of Nutritious Food Products (NFPs).
3. Implementing schools shall provide a documentation on the distribution of NFPs received by the beneficiaries and accomplished forms shall be submitted to the Division SBFP Coordinator for reporting, accounting and recording purposes.
4. A separate Division Memorandum shall be issued relative to the monitoring of the implementation of SBFP-NFP.
