DESIGNATION OF DIVISION SUB-COMMITTEES TO ASSIST THE HUMAN RESOURCE MERIT PROMOTION AND SELECTION BOARD (HRMPSB) IN THE CONDUCT OF THE INITIAL EVALUATION OF THE QUALIFICATION OF APPLICANTS AND COMPARATIVE ASSESSMENT FOR RECLASSIFICATION

- 1. Pursuant to **DepEd Order No. 24, s. 2025**, entitled "Guidelines on the Evaluation and Selection Process for the Reclassification of Teaching, Teaching-Related, and School Administration Positions," and its amendments under **DepEd Order No. 34, s. 2025**, the **Schools Division Superintendent (SDS)** is authorized to designate **sub-committee/s** in the districts or offices, as deemed practicable, to assist the **Human Resource Merit Promotion and Selection Board (HRMPSB)** in the conduct of the **comparative assessment process.**
- 2. These sub-committees shall serve as assistorial bodies to support the HRMPSB in ensuring efficiency, integrity, and transparency in the implementation of the reclassification process. The HRMPSB shall, however, retain full responsibility and accountability for the results of the comparative assessment and shall respond to all related queries and complaints.
- 3. Functions of the Sub-Committees

The designated sub-committees shall perform the following functions:

- a. Facilitate the initial screening, evaluation, and verification of submitted documentary requirements and Means of Verification (MOVs);
- b. Conduct pre-assessment and data consolidation of qualified applicants per district, level, or designated cluster;

- c. Carry out the Classroom Observation Instrument (COI) assessment of applicants and prospective applicants within their respective areas of assignment or designated cluster, composed of trained assessors preferably from the district or school level; and
- d. Submit validated results to the HRMPSB Secretariat for final deliberation.
- 4. The composition of the sub-committees shall consist of trained assessors who have completed the required programs under the Career Progression Assessors and RSP Capability Building initiatives. These assessors are qualified to apply established evaluation protocols and criteria essential for the reclassification process.as appropriate, to assist in the conduct of the comparative assessment process.

- 7. All activities and records shall be carried out with transparency, confidentiality, and accountability in compliance with existing civil service and DepEd policies.
- 8. All Expenses relative to the said activity shall be charged against local funds subject to the usual accounting and auditing rules and regulation.
