- 1. The Department of Education (DepEd), in partnership with **Canva Education**, is implementing updates to account settings to ensure a secure and seamless experience for all DepEd personnel using Canva's education platform.
- 2. To facilitate this transition, all users are reminded to follow the updated guidelines to ensure uninterrupted access to Canva Education.

#### 3. Information Dissemination

3.1. The Information and Communications Technology Service (ICTS) and Regional and Division Information Technology Officers (RITOs/DITOs) are requested to disseminate this advisory to all DepEd offices, including their teaching and non-teaching personnel.

## 4. Account Transition, Management and Security Updates

- 4.1. All users who are currently accessing Canva with non-DepEd email addresses are urged to transition to their individual official Microsoft DepEd accounts (e.g., name@deped.gov.ph) to ensure continued access to premium features and professional learning resources.
- 4.2. Accounts created using personal email addresses (e.g., Gmail, Yahoo, etc.) will no longer be recognized under the DepEd Canva tenant.
- 4.3. Office, administrator, regional accounts, or other shared credentials must not be used to log in to Canva.





4.4. The ICTS, in collaboration with Canva's technical team, is currently coordinating updates to account settings and authentication protocols. These enhancements are scheduled for implementation within October 2025. Following this update, access to Canva Education will be restricted exclusively to users with verified official DepEd accounts.

- 5.3. ICTS and RITOs/DITOs shall provide technical assistance to all users requiring support in migrating from non-DepEd email accounts to their designated official DepEd email accounts for accessing Canva.
