ADDENDUM TO DIVISION MEMORANDUM NO. 666, s.2025: NATIONAL CHILDREN'S MONTH: PROMOTING HEALTHY SMILES

- 1. Relative to Division Memorandum No. 666, s.2025 titled "National Children's Month: Promoting Healthy Smiles", this Office provides the following additional activities during the observance period:
 - a. Brush and Floss Challenge

Students are encouraged to follow the after-recess tooth-brushing and flossing routines. Teachers will allot time after recess for a supervised tooth brushing activity for the elementary level and a supervised toothbrushing and flossing activity for the secondary level (using school-provided or personal toothbrushing kits).

b. School Tick-Up Healthy Smiles Corner

A designated visible corner or board, where students can display artworks, posters, and pledges regarding oral health.

c. Classroom health talks and film showing.

During home room and MAPEH classes, brief health talks on oral hygiene shall be conducted, or a film presentation that visually reinforces the message shall be shown.

- 2. Furthermore, in reference to Notice of Distribution No. 19, s. 2025 "Notice of Distribution of Colgate Bright Smiles, Bright Futures Oral Health Bundles to Kinder and Grade 1 Learners in Public Schools for SY 2025-2026", the remaining Bright Smiles, Bright Futures (BSBF) Bundles shall be distributed to the target beneficiaries.
- 3. The completed BSBF school distribution form, narrative report on the National Children's Month Activities, along with the photo documentation, shall be submitted via email to bsbfphillipines@bsbfphils.com and a copy furnished to sgodmedical@deped.gov.ph, on or before November 21, 2025.

NATIONAL CHILDREN'S MONTH: PROMOTING HEALTHY SMILES

To: Schools Division Superintendents

1. In accordance with Republic Act No. 10661¹, which designates November of every year as National Children's Month, this office, through the Education Support Services Division encourages all Schools Division Offices (SDO) in CALABARZON to observe **National Children's Month: Promoting Healthy Smiles** from November 3 to November 28, 2025. This year's theme is "Bantayan, Ingatan, Karapatang Pang-ngipin ng Batang CALABARZON Ipaglaban!" which translates to "Protect and Uphold CALABARZON Children's Right to Dental Health!".

2. This aims to:

- a. recognize our learners as children who are valuable national assets deserving rights and protection for healthy smiles;
- b. raise awareness and promote the welfare of the learners in terms of oral health care and services; and
- c. promote activities in the school with the help of stakeholders, thereby encouraging participation, education, and advocacy for children's rights and well-being in terms of oral health.
- 3. Participants in this activity include the Dental Health Coordinators from the School Health and Nutrition Section, school administrators, teachers, health advocates, and learners.
- 4. The dental personnel and other school health staff in the SDOs of Calabarzon will lead the planning of activities related to the observance of National Children's Month. This may involve the distribution of Oral Health Kits to learners and the implementation of Oral Health Education and Awareness.
