**UTILIZATION OF RO-PROCURED LEARNING RESOURCES
DURING THE IMPLEMENTATION OF ALTERNATIVE
DELIVERY MODALITIES (SYNCHRONOUS
AND ASYNCHRONOUS)**

To **Schools Division Superintendents**

1. Pursuant to the implementation of learning continuity measures during class disruptions or suspensions declared by Local Government Units (LGUs) due to calamities, disasters, and other emergencies, this Office directs **all Schools Division Offices (SDOs) to ensure the immediate use and access to available Learning Resources to sustain teaching and learning delivery.**
2. The following RO-Procured Learning Resources (LRs) shall be utilized by learners and teachers when Alternative Delivery Modalities (Synchronous and Asynchronous) are activated:
 - a. Transition Learning Resources (LRs) for Kindergarten, Grades 1, 2, 3, 4, 5, 7, and 8
 - b. Self-Learning Modules for Alternative Delivery Mode (SLM-ADM) for Grades 6, 9, and 10
 - c. Dynamic Learning Program – Learning Activity Sheets (DLP-LAS) for Junior High School (JHS) and Senior High School (SHS)
3. **All SDOs are reminded to ensure that the RO-procured learning materials are readily available and accessible for teachers and learners during class suspensions to sustain learning delivery. Soft copies of these materials are likewise accessible to the SDO Learning Resource (LR) teams through the Regional LR shared repository.**
4. In addition, SDO-procured or SDO-initiated learning materials may also be utilized to complement the RO-procured resources, provided that these have undergone the required quality assurance and evaluation process in accordance with existing DepEd guidelines.
