To ensure that the program is being implemented at home by the learners the following are the Roles and Responsibilities.

#### **ROLES AND RESPONSIBILITIES:**

Regional Supervising Dentists must:

 a. Monitor the distribution and implementation of the program.
 b. Ensure complete and on time submission of COA, DMF and SMF of the Schools Division offices.

2. Division Dentists must

a. Cascade the Implementation Guidelines to the School Heads and Grade Leaders.

- Coordinate with the school heads to ensure the proper distribution of Oral Health kits to the
- c. Discuss with the grade leaders how proper hygiene and oral health awareness can be included in virtual activities
- d. Share relevant BSBF materials to the grade leaders to support/provide additional learning tools about oral health.
- e. Provide Colgate BSBF Team a monitoring update through pictures submitted by the grade leaders during the BSBF activity.

  f. Ensure that all School heads will submit the School monitoring form to the Division Dentists
- g. Collate all School Monitoring Forms and Pictures then scan and email it to bsbfphilippines@gmail.com

    - i. BSBF Kits: 1 kiddie TB/1 sachet TP and Leaflet.
    - ii. Letter to Parents
  - b. The distribution of kits is dependent on how the schools send out their learning materials to the learners
  - c. Inform all parents about the program and how it should be implemented via the following communication channels
    - i. Social Media Group
    - ii. Text Message
    - iii. Other means of communication
  - d. Once the kits are received by the learners, include this activity in the daily hygiene program.

- e. Document all activities through a picture and ensure to send a copy to the school head and division in charge dentist.
- Parents or Guardians must:

   Coordinate with the Grade Leaders upon the receipt of BSBF kits
   Supervise their child/ward in Brushing their teeth 3x a day everyday.
  - b. Ensure that proper hygiene is maintained even at the comfort of their house.
  - c. Additional Educational material is included in the kit to help them educate their child/ward.

- b. After receiving the BSBF Boxes, please sign the BSBF Division Monitoring Form.
- c. Once BSBF Boxes are in your school, the program must be initiated immediately to ensure that Toothpaste and Toothbrushes will be distributed within the program timetable.
- d. A photo documentation of the distribution is encouraged and shall be emailed to bsbfphilippines@gmail.com.
- e. After distribution, school heads are required to accomplish the SCHOOL DISTRIBUTION FORM. Once accomplished, School Distribution Form must be submitted to the Division Dentists.
- f. After submitting the SCHOOL DISTRIBUTION FORM, please text us the following details to keep track of your school's accomplishment:
